PUBLIC FORUM - No members of the public were present.

- 6.143 APOLOGIES Apologies from Cllr Jones were accepted.
- 6.144 DECLARATION OF INTERESTS CIIr Hill declared an interest in P07/0206.

6.145 CONFIRMATION OF MINUTES

The minutes of the meeting held on 5th February were approved and signed as a correct record.

6.146 PARISH AFFAIRS

<u>146.1 Village policing/antisocial behaviour</u> – PC Maple reported on recent incidents. In response to queries about street parking he informed the Council that in future there would be 35 parking wardens working within the Borough and that Audlem could expect to be visited daily. Deployment of the Parish Council's CCTV unit around the village was bearing dividends. <u>146.2 Youth Council</u> – The Chairman reported that a committee meeting had taken place on the 26th February to agree the format of the flyer for distribution to households. The event would take place at 7 pm on Monday 12th March in the Committee Room of the Public Hall. <u>146.3 Ambulance response times</u> – ClIr Hill reported that the matter had been brought to the attention of the Minister for Health by Stephen O'Brien MP and that senior managers of the Ambulance Service had been instructed to attend a meeting in Audlem with Mr O'Brien. ClIr Allan Richardson had also taken the matter up and the deputy head of the Ambulance Service would be speaking to the Council on 14th March. The formal response to the Parish Council's letter of complaint dated 17th January was received.

146.4 Public toilets - CNBC would carry out work before the end of the financial year.

146.5 Fencing at children's playground - Response from CNBC awaited.

<u>146.6 Temporary closure part public car park</u> – CNBC Estates Department reported that they had discussed the closure with Borough Councillors before authorising the work and apologised for lack of local consultation. British Waterways had indicated that work was currently ahead of schedule.

6.159 PARISH PLAN - AUDLEM VALE

Cllr Hill reminded Members of his informal discussions and negotiations with the owner of Bath House Farm. Following receipt of Barbers' letter of 22nd February investigations into land values and costs had been undertaken and it was estimated that if the Parish Council took out a Public Works Loan (4.85% fixed over 25 years) the cost of repayment in terms of Council Tax would be an additional £4 (approx.) per annum for Band D homes. Legal and valuation costs, estimated at less than £1,500, could be included in the loan.
