PUBLIC FORUM

Insp Brierly and Sgt Morton advised on future policing arrangements and answered Councillors' questions about recent incidents. The Chairman thanked the officers for attending the meeting. Two residents expressed concern at proposals contained in planning application P04/0275.

Resolved:

P05/0313 First floor rear extension (resubmission P04/1107) at Sunnyside Cottage, Longhill Lane; P05/0308 2 Storey rear extension (resubmission P04/1072) at Sunnyside, Longhill Lane; P05/0332 2 Storey side extension etc at Little Heath Cottage, Corbrook; P05/0198 Extension to car park and electricity sub station at Corbrook Court Nursing Home (amended plans)

(2) that the Parish Council object to the development proposed in P05/0275 Extension & 1 new dwelling in garden area at 44 Stafford Street for the following reasons: (a) there is insufficient space on the site for an additional dwelling, therefore over domination and loss of amenity for the owners of the neighbouring property would result; (b) the proposed dwelling would be aesthetically inappropriate in a conservation area; (c) there would be an adverse impact upon highway safety with additional vehicles accessing the site in a hazardous area subject to an experimental traffic control scheme. There is no objection to proposals for a 2 storey side extension to the existing house.

Negotiations with Scotpower were taking place regarding an outstanding power bill and following an inspection of the kitchen by Environmental Health a replacement floor was required.

Pot holes had appeared between Manor Farm and Laurel Farm, and outside Manor Farm. A representative of disabled organizations had inspected facilities at St James' Church and had recommended ramps and a disabled parking bay outside the east gate.

The 30 mph sign on Whitchurch Road was not flashing, also the flashing sign on Woore Road by the Baptist Chapel was out of alignment.
