# (a) Resolved: that no objection be made in respect of -

P06/0228 Amendment to planning permission P04/1440 Relocation of porch, Orchard Cottage, Cox Bank

P06/0242 One dwelling on land adj 47 Cheshire Street

P06/0275 Change of use from ancillary building & holiday accommodation to dwelling @ Brookside, School Lane

P06/0186 Conversion of agricultural building to 1 dwelling @ The Dairy, Bagley Lane.

- (b) Resolved: that the Parish Council object to proposals contained in P06/0214 Change of use of land & formation of new access drive @ Ivy Cottage, Woore Road for the following reasons:
  - i) The proposed development would be detrimental to highway safety. The property already has adequate access and the proposed new access would increase hazards by intensifying use of the Mt Pleasant/Woore Road junction where there is poor visibility. Sight lines are shorter at this road junction than at the existing access direct onto Woore Road.
  - ii) Mt Pleasant is overcrowded, in poor condition and is unsuitable for the amount of traffic already using it.
  - iii) The application proposes inappropriate use of agricultural land. There is no gate or other access from the field onto Mt Pleasant.

Resolved: that no objection be made.

#### 5.238 PARISH AFFAIRS

Parking on Shropshire Street & The Square/Audlem Tree House

The meeting on 28th March had been well attended and problem areas - The Square, Heathfield Road, corner of Hillary Drive and Heathfield Road, Churchfields, A525 and Sandy Lane corner – had been discussed with the Highways Engineer. It was agreed that CNBC should be requested to remove the overnight parking restriction in the car park.

Marking of car parking bays in public car park – It was noted that a response from CNBC was awaited.

<u>Teen Shelter</u> – Cllr N Huntbach said that investigations were continuing and that he would report back at the next meeting.

<u>Children's playground</u> – CNBC had advised that although the playground equipment was dated it was safe and complied with British Standards. However, efforts would be made to find funding for improvement. Councillors agreed that an independent inspection might be helpful. At the moment the playground was not dog-proof.

Composting site - Response from CNBC awaited.

Village stationery

Resolved: that Cllr Mrs P Seddon, Cllr M Hill and Cllr B Consterdine form a subcommittee with the power to make a decision on design.

Cllr Hill reported that the group had submitted applications for grants for various projects. In respect of the Annual Parish Meeting on 11th May, it was agreed that the event should be publicized throughout the village as the "Annual Village Meeting". The Clerk provided guidelines on the conduct of parish meetings.
