## **PUBLIC FORUM**

Mr Millns and Mr Cartwright, for Audlem Medical Practice Patient Panel, spoke about contractual difficulties between Western Cheshire and North Staffordshire Primary Care Trusts likely to result in practical problems for patients. Residents of Moorsfield Avenue reported on recent dealings with United Utilities and CEC regarding responsibility for sewers on new estates.

10.114 FORMATION OF TRUST – "AUDLEM & DISTRICT COMMUNITY ACTION" – Cllr Hill reported that local efforts had been successful and that a Trust was now being formed to protect services delivered from Thornton House. Thanks were due to Cheshire East Council officers for their co-operation and to Mr Millns for his determination and expertise. Cllr Mrs Christie would act as the Parish Council's representative to the Trust. At the Chairman's invitation, Mr Millns spoke to thank everyone for their enthusiasm and support.
