Before business commenced, Mr David Marren (Executive Director, Crewe & Nantwich Borough Council) explained the Borough Council's perspective on proposals for a unitary system of local government in Cheshire. The Chairman thanked him for attending the meeting.

7.23 CONFIRMATION OF MINUTES

The minutes of the Parish Council meeting held on 14th May and the minutes of the Annual Village Meeting held on 24th May were approved as correct records and signed by the Chairman.

7.24 PARISH AFFAIRS

24.1 Village policing/antisocial behaviour – Nantwich Police Station had indicated that concerted action would be taken in the near future to deal with ongoing problems.

<u>24.2 Youth Council</u> – The Parish Council had been given the name of a contact at Brine Leas but as yet the Clerk had been unable to establish contact.

<u>24.3 Ambulance response times</u> – It was regrettable that the public meeting on 7th June had been poorly attended (about 30 residents) despite the presence of Stephen O'Brien and 5 senior officers from the Ambulance Service. Assurances were given that the Ambulance Service was working hard to establish an equitable service and improve response rates throughout the region. There had been a lengthy question and answer session.
