#### 5.09 PLANNING & DEVELOPMENT

P05/0472 Demolish existing house and construct 8 detached houses with double garages @ Moorsfield House, Moorsfield Avenue

Resolved: that whilst there is no objection in principle to development on the site, objection should be made to the present proposals as follows:

(1) increased traffic hazards at the A525 junction with Moorsfield Avenue during site works and following completion of the scheme; (2) the proposed development will be tapping into an unadopted sewerage system; (3) housing density in the surrounding area is low and it is therefore considered that the density proposed is inappropriate, especially on such a small, narrow site; also that attention be drawn to the obligation to provide affordable housing and the existence of Tree Preservation Orders in the area; and that a site visit to be requested.

P05/0486 Conservatory @ 10 Salford

Resolved: that no objection be made.

P05/0381 Extension to provide 24 additional bedrooms etc. @ Corbrook Court

Resolved: that the response made on 3rd May be noted, i.e. that the existing septic tank arrangements would be inadequate; and that increased traffic would join the A529 at a point where visibility is limited.

Other planning items were noted.

5.10.1 Proposal for Audlem Civic Roll of Honour

Resolved: that ideas be discussed at the next meeting.

5.10.2 Drinking in public places

Cllrs Consterdine and Hill had met with Insp Paul Jennings to discuss the above and had been assured that remedies were available to the Police to combat this problem if the Parish Council requested help.

#### 5.10.3 Benches

Three picnic benches had been received from S Dunne and were being prepared for installation. A letter from ADAS was tabled containing details of an offer by Mr D Hodgkins of Cox Bank to pay for re-installation of suitable benches on the perimeter of the playing field.

Resolved: that the Chairman speak to Mr Hodgkins to thank him for his kind offer and advise him of the Parish Council's current intentions with regard to benches in this location.

Resolved: an official order be placed with SPG in the sum of £314 for the supply and installation of bike stands as discussed.

Prices were being obtained for a tarmac drive up to the Chapel and Dodcott-cum-Wilkesley Parish Council were conducting a referendum on a proposal to re-join the Burial Committee.

Cllr Stretch reported that, thanks to the generosity of the Watch Your Weight group the snooker table had been re-covered. A list of projects for the coming year was being prepared and, following a reassessment by the Fire Brigade, the capacity of the Hall was now deemed to be 200.
