9.02 ELECTION OF CHAIRMAN

9.06 CONFIRMATION OF MINUTES

06.1 Minutes of the Parish Council meeting held on 6th April

The minutes were approved and signed by the Chairman as a correct record of the meeting. 06.2 Notes of Annual Village Meeting held on 4th March

9.07 PARISH AFFAIRS

<u>07.1 Village policing</u> – Councillors discussed the recent spate of burglaries, current status of Homewatch groups, and illegal parking in The Square. The Clerk was instructed to (a) ask the Homewatch Co-ordinator to attend a future meeting; (b) request more frequent irregular visits by parking wardens. Cllrs Furber and Stretch would also raise these matters at the next Cluster meeting.

<u>07.2 Children's playground</u> – Cllr Morgan had provided more evidence of need/consultation to support the bid for funding. WREN would advise on the outcome at the end of June at the earliest. On behalf of the Playground Committee, Cllr Mrs Christie thanked Cllr Morgan for his work.

<u>07.3 Footpaths from playing field to Shroppie Fly</u> – Cheshire East had recently advised that the Parish Council's 2005 application for an amendment to the Definitive Map was still on its waiting list and had yet to be allocated to a member of staff.

Resolved: that Cheshire East PROW Team be urged to expedite action.

<u>07.4 First Responders</u> – Cllr Hill reported that five more volunteers would undertake basic training in the coming week and that at the present time First Responders could assist at only a limited range of incidents. A referendum to gauge the views of residents was being organised. The Clerk was instructed to remind NWAS that it had failed to report on response times to 31st March as promised.

<u>07.5 Lengthsman's workload</u> – Cllrs Consterdine and Hill agreed to liaise with the lengthsman in order to pass on Councillors' requests, instructions, etc.

<u>07.6 No.73 Nantwich to Whitchurch bus service</u> – Cllr Hill reported that residents were unhappy that the bus service had been re-routed some time ago and no longer passed Emberton Place. The Clerk would bring this to the attention of Cheshire East, plus residents' plea for reinstatement of the Wednesday Market Drayton service.

07.7 Refund for brown bin garden waste collection service April - July 2009 – It was noted that Cheshire East would make refunds on application by an individual. Councillors agreed that this appeared unnecessarily bureaucratic and unhelpful. Cllr Mrs Bailey supported this view and was making representations on behalf of Audlem.

Resolved: that the Parish Council make a complaint to Cheshire East Council.

Cllr Mrs Bailey placed on record her thanks to the retiring Chairman for his co-operation during his term of office. She also congratulated Cllr Mrs Down on her appointment as Chairman.

<u>07.8 Land at Paddock Lane</u> – Cllr Morgan reported that the land in question had been vested in Highways at some point in the past. He had noted noxious weeds on the land and suggested that, once they had

been treated, the area levelled and a trench installed to prevent parking, the Parish Council might wish to consider a planting scheme to make the area less unsightly.

Resolved: that Cheshire East Council be asked to treat noxious weeds, level the area and dig a trench to prevent access by vehicles.

- 10.4 Outstanding works Cllr Bradbury-Smith had been advised by John Dodd (new local Highways Officer), that remedial work to the road surface at Corbrook would be carried out before any new works in the area in July/July. Following the harsh winter, Mr Dodd aimed to meet with every Parish Council to discuss a maintenance programme in order to report back to Cheshire East by 1st July.
