6. Nature report

Neil Goodyear provided an update on tree planting update and the idea of planting a new hedge behind the Shropshire street hedge if/when the decision was taken to widen the roadside footpath. It was also reported that Woodland trust are now taking applications for March planting. IN discussion it was agreed that not everyone will be in favour of planting more trees but as Cheshire Wildlife Trust advised, the planting trees now to take over from the oaks should be considered noting that keeping the south view from the north field be kept as open as possible.

The group was advised of the RHS launch of the "plant a remembrance tree" campaign and the potential planning for the Queens Platinum Jubilee in 2022.

II. Green Car Park

The group were advised that Mr David Higham has offered to provide additional information from work he did earlier. The group agreed that his input could prove very useful. Cllr McLaren Brown and the Clerk will maintain the contact. The Clerk has been in contact with 'Greentech' who provided a quotation to Mrs Lynette Hopkins last year. This has been followed up with them confirming that costs would be held as per the quotation. Contact was confirmed with Gary Chesters (Architect based in Weston, Shrewsbury) who has previously provided a quotation via David Higham. Greentech have referred the Council to Landstruction (Landscape Contractors) based in Chester with a view to them quoting to carry out the groundworks. Clerk has subsequently contacted both parties with a view to conducting a site visit in order to consider the project further, provide outline views and in the case of Gary Chesters to prepare outline drawings leading to submission to CEC Planning



Consideration must be undertaken to establish levels of insurance either required or already in place to cover all voluntary activities that may be undertaken either on behalf of the Parish Council and/or in association with the Parish Council.

Consideration still needs to be given to the number of Councillors on the group (Next Parish Council meeting) and/or to consider the terms of reference which states the group make up.
